Voters services, including voter registration, voter education and get out the vote activities, are the highest priority program for the League. In person voter registration was severely restricted due to health protocols during the global pandemic, but the League turned to social media and other methods to continue efforts that focused on underserved communities. To help everyone vote safely during the pandemic, the League was one of the first organizations to promote vote by mail. Volunteers made 308,108 phone calls and text messages for registration and get out the vote. Social media was an important education tool, and the League had a Facebook Reach of over 6.6 million between August 18 and November 3. To support outreach to communities of color, four different radio ads were placed on stations with a high percentage of African American listeners and six newspaper ads were printed in publications popular with African Americans and Hispanics. In partnership with Alpha Kappa Alpha sorority, 49,536 people were reached with get out the vote messaging on social media. Local League members and volunteers distributed 149,075 printed Voter Guides. An additional 126,918 Voter Guides were distributed as inserts through three African American and two Hispanic focus newspapers. Revenues include grants for these program activities.

4b (Code:) (Expenses \$ 190,051 including grants of \$ 0) (Revenue \$ 190,051)

The League worked to help returning citizens who have been convicted of a felony and completed their sentence to register to vote, become aware of candidates and issues, and then vote in 2020. From a list of 64,548 returning citizens that League volunteers contacted, 21,748 people successfully registered to vote. A phone hotline was established as a resource for returning citizens with questions about their ability to vote. League members created training programs for attorneys in how to assist returning citizens. The training was presented in multiple locations and qualified attendees for Continuing Legal Education. 185 volunteers representing 23 local leagues throughout the state mailed 184,000 postcards to returning citizens. Additional partner organizations mailed 155,000 postcards. The League was first among voter services organizations to have a webpage with messaging for returning citizens and the League website had over 1.8 million pageviews between September 9 and Election Day November 3. A social media microtargeting campaign with partner organization ACLU reached 10,234 returning citizens. Revenues reported for this program are grants and restricted contributions.

The League supports local League of Women Voters entities throughout the state by acting as fiscal agent for grants and contributions. During the year, the League of Women Voters of St. Petersburg Area received additional grants for voter engagement and educational programs that were administered by the organization. In addition, programs at multiple local League of Women Voters entities were enhanced by gifts to and payments by the organization on their behalf. Revenues include grants and donations restricted for use by local leagues.
